SUBJECT: Annual Crime Analysis Report for 2013

*The annual report includes general information on **Part 1** and selected **Part 2** crimes reported and investigated by the Guilford Police Department. The report also includes information on motor vehicle enforcement, accidents, and alarm cases investigated by this agency from **January 1st, 2013 to December 31st, 2013**. A comparison on all information is also listed for the previous year.*

Calls for Service

During 2013 the Guilford Police Department received **11,915** calls for service. Of these calls the following information has been formulated for your review. During the same period in 2012 there were **12,386** calls for service. This was a **decrease** of almost **4 %** in calls for service from the previous year.

Burglary Cases

There were a total of thirty-seven (**37**) burglaries reported during this period. The majority of which were residential in nature. During the same period for 2012 there were fifty-eight (**58**) reported burglaries in the jurisdiction. This was a **36% decrease** from the previous year.

Criminal Mischief Cases:

There were a total of one hundred and eighty three (**183**) criminal mischief complaints reported during this period. The majority of which were private property and or mailbox damage. During the same period for 2012 there were two hundred and twenty-three (**223**) cases reported. This was a nearly **18% decrease** from the previous year.

Larceny Cases:

There were a total of two hundred and sixty four (**264**) larceny complaints filed during this period. The majority of which were classified as general larceny in nature. In addition identify theft cases, and fraud cases have been added to this year's report. During the same period for 2012 there were four hundred and seventy-eight (**478**) cases reported. This was a nearly **45% decrease** from the previous year.

Motor Vehicle Enforcement

There were a total of two thousand eight hundred and ninety eight (**2,898**) motor vehicle violations investigated during this period. During the same period for 2012 there were three thousand one hundred and forty eight (**3,148**) cases investigated. This was a nearly **8% decrease** from the previous year.

There were forty-two (**42**) **DWI** arrests in 2012 and fifty-two (**52**) **DWI** arrests in 2012. This was a **19 % decrease** from the previous year.

Motor Vehicle Accidents

There were a total of five hundred forty three (**543**) motor vehicle accidents investigated during this period. Three (**3**) of these was fatal. There were also sixty one (**61**) evading responsibility complaints investigated. During the same period for 2012 there were eight hundred and six (**806**) motor vehicle accidents investigated, (**1**) of which was fatal. Fatal accidents **increased 200%**. The total **decrease** in accidents was nearly **33%** overall, not including evading complaints.

During this reporting period there were two hundred fifty nine (**259**) child safety seats installed by officers of this department. During the same period for 2012 there were one hundred thirty six (**136**) child safety seats installed. A **90% increase** from the previous year.

Narcotics/Drugs

There were a total of twenty-four (**34**) drug related cases investigated during this period. During the same period for 2012 there were twenty-four (**24**) cases investigated. This was a nearly **42% increase** from the previous year.

Sex Crimes Cases:

There were a total of five (**5**) sex crime related cases investigated during this period. During the same period for 2012 there were ten (**10**) cases investigated. There was a **50% decrease** from the previous year.

Robbery Cases:

There were zero (**0**) robbery cases investigated during this period. During the same period for 2012 there was five (**5**) cases investigated. This was a **500% decrease** from the previous year.

Alarms All types

The department responded to a total of one thousand three hundred thirty two (**1,332**) alarms during this period. During the same period for 2012 the department responded to a total of one thousand four hundred forty two (**1,442**) alarms. This was a nearly **8% decrease** from the previous year.
