Crime Analysis

A set of systematic, analytical processes directed at providing timely and pertinent information relative to crime patterns and trend correlations to assist the operational and administrative personnel in planning the deployment of resources for the prevention and suppression of criminal activities, aiding the investigative process, and increasing apprehensions and the clearance of cases. Within this context, Crime Analysis supports a number of department functions including patrol deployment, special operations, and tactical units, investigations, planning and research, crime prevention, and administrative services (budgeting and program planning). --Steven Gottlieb et al., 1994, "Crime Analysis: From First Report to Final Arrest."

SUBJECT: Crime Analysis Report January 2010

*During the month of January 2010. The Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information. This information was compiled via the AS400 system utilizing a query of all Part 1 Crimes and select Part 2 crimes from the computer database. A review of each queried case file report was completed.*

A user friendly interactive website is available through www.crimereports.com In addition to the information and graphs listed below. The crime reports link also catalogs and provides crime graphs and trends which allow officers and supervisors to better direct their patrols in preventing crime in the town. The crime reports site links all calls for service in the town.

The Guilford Police Department responded to 926 cases for the month of January.

Burglary Cases

There were a total of (8) burglaries reported during this period. Three were commercial in nature, and five were residential. Four of the burglaries were classified as forced. One of the burglaries was solved via arrest. Of the (8) two were attempted burglaries. Two of the commercial burglaries showed distinct patterns and modes operandi. A video of the suspect is being analyzed. Reference Appendix B for a graphic representation.

Criminal Mischief Cases:

There were a total of (14) criminal mischief cases filed; five were mailbox damage, eight were private property, and one was public property. One of the cases was solved via arrest. Three of the cases had a distinct pattern or modes operandi. These three cases were all paintball incidents on the same evening. Reference Appendix C for a graphic representation

Larceny Cases:

There were a total of (23) larceny complaints filed. A detailed examination of these cases revealed the following details: Of the twenty-three cases, five were solved. A total breakdown of the types of larceny cases are as follows: (3) theft from buildings, (5) theft from a motor vehicle, (11) general larceny cases, (2) shoplifting cases, and (2) motor vehicle thefts. Three cases at Guilford High School were similar in nature. Three cases showed a distinct pattern or modes operandi all occurring on the same evening in the same localized area in which vehicles were broken into, and items taken. Information and Intelligence received on criminal activity:

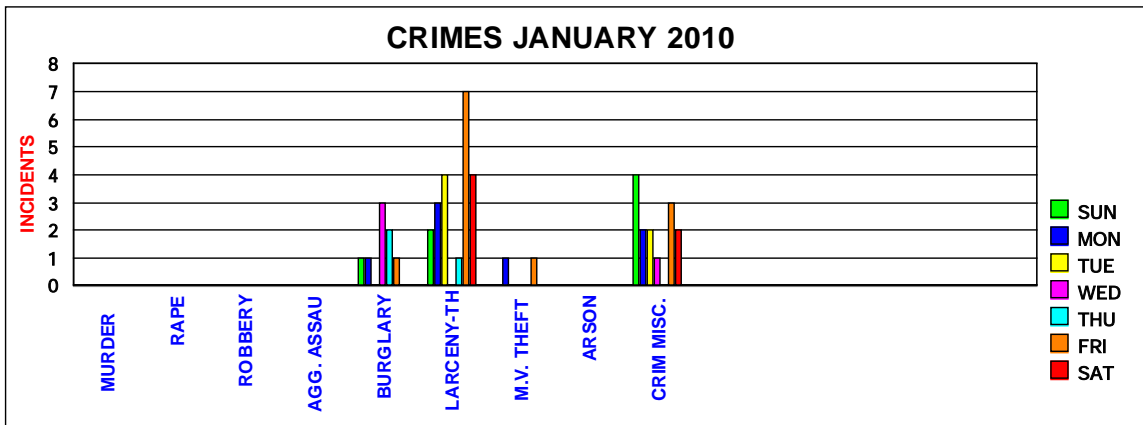
