A set of systematic, analytical processes directed at providing timely and pertinent information relative to crime patterns and trend correlations to assist the operational and administrative personnel in planning the deployment of resources for the prevention and suppression of criminal activities, aiding the investigative process, and increasing apprehensions and the clearance of cases. SUBJECT: Crime Analysis Report January 2009

During the month of January 2009. The Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information.

#### Burglary Cases

There were a total of eight (8) burglaries reported during this period. Six were residential in nature. The remaining two were commercial. Four were forced. Three were solved all involving the same suspect. Arrest warrant applications are pending in the solved incidents. Three of the burglaries did show a distinct pattern as well as a modes operandi. *Reference Appendix B for a graph representation.* 

#### Criminal Mischief Cases:

Five (5) criminal mischief cases were filed; one was public property, three were mailbox damage, and one was private property. One of the cases was solved. No arrests were made as the suspect made arrangements with the owner to replace the damage items. No distinct patterns or modes operandi were noted in these cases. *Reference Appendix D for a graph representation.* 

#### Larceny Cases:

Fourteen (14) larceny complaints were filed. A detailed examination of these cases revealed the following details: Of the fourteen cases, a total of seven (7) cases were solved. Three of the solved cases resulted in arrests. A total breakdown of the types of larceny cases are as follows: (2) shoplifting cases. (1) theft from a building, (3) thefts of autos, (1) theft from a motor vehicle, and (7) general larceny cases. No distinct patterns or modes operandi were noted in these cases *Reference Appendix C for a graph representation*.

#### Robbery Cases:

There was one robbery reported during this period. The robbery was strong-armed in nature and is still under investigation. There were no injuries in this incident. a suspect has been developed.

#### Arson Cases:

There was one arson reported during this period. Very minor damage to a barn on the Boston Post Road occurred. The case is still under investigation.

#### Rape Cases:

In accordance with Connecticut General Statutes details of all sexual assault cases details remain sealed.

#### Murder Cases:

None reported

#### Information and Intelligence received on criminal activity:













**Burglary Cases for January 2009**











Larceny Case for January 2009
