3.2. Traffic request-Neck Road/Circle Beach.

Chief Hutchinson reviewed correspondence with the Commission including a visual map of Neck Road and Circle Beach. He reviewed the history of the location. Chief Hutchinson and Commissioner Mikolay took a good look at the concerns regarding parking including the configuration of the homes, the state boat launch and the town beach. The Chief stated the Municipal Animal Control Officer has been monitoring the area and the neighbors are appreciative. He reported that officers are patrolling the area at the appropriate times, designated by the Chief of Police.

Chief Hutchinson recommended that the department continue a patrol presence and continue the monitoring of the location with the animal control officers.

Chief Hutchinson reported on meeting with town officials regarding the food truck concerns and said Ms. Millman, Town Attorney is in the process of reviewing an ordinance and peddler regulations.

Discussion followed regarding parking signs around the green. The Chief and the Commission agreed that they will continue to work with the town departments, business owners and residents regarding the food trucks. It was agreed no action would be taken until the new regulations have been finalized.

## 3.7. Vineyard Point Road.

Commissioner Mikolay gave an update on Vineyard Point Road. He reported that the neighbors are continuing to research historical documents and expect to have the final results within the next two weeks.

Chief Hutchinson reported that this was a tabled item from last month's meeting. It was discussed and reported that the brush has been cleared. The Chief is continuing working on the guard rails with Mr. Portley, Town Engineer.

Chief Hutchinson replied that the Parks and Recreation Department and the Town Facilities Department are supposed to work on the landscaping of the shrubs, mulching, weeding, etc. but it has been difficult scheduling the work through the town departments. It was discussed and agreed that the property should be groomed and maintained.

Chief Hutchinson reported that Lieutenant Provencher received quotes to have a private vendor to take over the landscaping work. Discussion followed.
