## 2. Public Petition/Commentary.

Chairman Hedberg opened the discussion to Mr. Joseph Nugent, Resident of 423 New Whitfield Street.

Mr. Nugent provided a visual to the Board of Police Commissioners and stated he was present to discuss "a quality of life issue in Guilford". The discussion was about people who walk dogs and litter the waste bags on Whitfield Street, the Town Green and the surrounding areas including Chittenden Park. Mr. Nugent recommended the installation of receptacles at Chittenden Park.

The Chief of Police responded that the Municipal Animal Control Officers will continue to check the areas for violations. The Chief will check the ordinance, increase public awareness using the new MACO Facebook page and will increase patrols. Chief Hutchinson recommended that Mr. Nugent contact the Parks and Recreation Director regarding many of the concerns which are related to that department. Chairman Hedberg agreed that Parks and Recreation should be contacted.
