## 3. Traffic.

3.1. Traffic related correspondence submitted as information-Hamblett and Banks (F.Y.I.).

This traffic item was presented as informational correspondence sent from the Chief of Police in response to traffic items on last month's Agenda.

3.4. Crash Investigation Analysis Church Street: U.S. 1 to Broad Street (F.Y.I.).

The Deputy Chief of Police researched traffic concerns from U. S. 1 to Broad Street and a Crash Investigation Analysis Report was provided to the Board of Police Commissioners. The analysis provided statistics. Discussion took place and no action was taken.

3.5. Anonymous Traffic correspondence forwarded from the First Selectman's Office (F.Y.I.).

Chief Hutchinson stated the anonymous correspondence included traffic concerns that were already being addressed by the department.

3.6. Kids Hugs Organization-Bike Ride request.

Chief Hutchinson and Deputy Chief Dunn met with several representatives of the Kids Hugs Organization prior to this meeting regarding a request for an organized bike ride in Guilford for children. The bike ride normally is scheduled at Hammonasset State Park in Madison, but due to construction in 2016 there will be no organized events at that park.

The Chief reviewed his recommended route for the bike ride with the Commissioners. A question and answer discussion took place including the Kids Hugs representatives who were present. The Parks and Recreation Department has preapproved the use of Jacobs Beach where the ride will originate and terminate.
