# 7.1. Welcome Commissioner Frey

## 3.6. Guilford Half Marathon and 5k.

The Board of Police Commissioners opened the floor to Ms. Jody Damsky. She presented the Police Commissioners with a packet and spoke about the Guilford Half Marathon and 5k which regularly takes place at Hammonassett State Park in Madison. The race must relocate this year due to the construction at the State Park.

The proposed road race would be held on Sunday, November 6, 2016 and begin at the Guilford Fairgrounds. Ms. Damsky works for JB Sports who is contracted by the Madison Rotary Club to run the road race.

Chief Hutchinson reviewed several concerns regarding the location of the road race, the forecasted number of runners, traffic and safety concerns and patrol staffing issues. The Board of Police Commissioners agreed with these concerns.

The Board of Police Commissioners communicated that there had been a request for a road race submitted a week prior to this request. That proposed race is on the same weekend. It was recommended by the Board of Police Commissioners that the Guilford Half Marathon and 5k organizers consider an alternate date. An alternate date of November 13, 2016 was requested. Chief Hutchinson offered his recommendation and discussion followed.
