SUBJECT: Annual Crime Analysis Report for 2015

The annual report includes general information on **Part 1** and selected **Part 2** crimes reported and investigated by the Guilford Police Department. The report also includes information on motor vehicle enforcement, accidents, and alarm cases investigated by this agency from **January 1**st **0000hrs**, **2015 to December 31**st **2359hrs**, **2015**. A comparison on all information is also listed for the previous year.

Calls for Service

During 2015 the Guilford Police Department received **12,118** calls for service. Of these calls the following information has been formulated for your review. During the same period in 2014 there were **11,772** calls for service. This was a **3.78** % **increase** in calls for service from the previous year.

Burglary Cases

There were a total of twenty-seven (27) burglaries reported during this period. The majority of which were residential in nature. During the same period for 2014 there were nineteen (19) reported burglaries in the jurisdiction. This was a 42.1% increase from the previous year.

Criminal Mischief Cases:

There were a total of one hundred and twenty-four (124) criminal mischief complaints reported during this period. The majority of which were private property and or mailbox damage. During the same period for 2014 there were one hundred and thirty-five (135) cases reported. This was a 8.87% decrease from the previous year.

Larceny Cases:

There were a total of four hundred and forty-one (441) larceny complaints filed during this period. The majority of which were classified as general larceny, larcenies from vehicles and shopliftings. In addition identify theft cases, and fraud cases have been added to this year's report. During the same period for 2014 there were four hundred and twenty-three (423) cases reported. This was a 4.25% increase from the previous year.

Motor Vehicle Enforcement

There were a total of three thousand eight hundred and thirty-two (3,832) motor vehicle violations investigated during this period (to include radar/laser speed enforcement and DWI enforcement). During the same period for 2014 there were three thousand two hundred and forty (3,240) cases investigated. This was an 18.27% increase from the previous year.

Included in the above statistic, there were forty-six (46) DWI arrests in 2015 (both alcohol and drug related) compared to twenty-four (24) DWI arrests in 2014. This was a 91.66% increase from the previous year.

Not included in the above statistic, the Guilford Police Department also investigated two hundred and four (204) parking complaints in 2015.

Motor Vehicle Accidents

There were a total of five hundred forty (540) motor vehicle accidents investigated during this period. Two (2) of these were fatal. In addition, there was also ninety one (93) evading responsibility complaints investigated. During the same period for 2014 there were five hundred and fifty-eight (558) motor vehicle accidents investigated, (2) of which were fatal. Fatal accidents remain consistent. The total decrease in accidents was 3.33% overall, not including evading complaints.

During this reporting period there were three hundred and eleven (311) child safety seats installed by officers of this department. During the same period for 2014 there were two hundred and twenty-five (225) child safety seats installed. A 38.22% increase from the previous year.

Narcotics/Drugs

There were a total of twenty-nine (29) drug related cases investigated during this period. During the same period for 2014 there was also twenty-nine (29) cases investigated. This was no change from the previous year.

Sex Crimes Cases:

There were a total of twenty (20) sex crime related cases investigated during this period. During the same period for 2014 there were one hundred and eight (108) cases investigated. There was a 540% decrease from the previous year. The dramatic decrease is due mainly a single suspect creating several individual cases.

Robbery Cases:

There were three (3) robbery cases investigated during this period. During the same period for 2014 there was two (2) cases investigated. This was a 50% increase from the

previous year.

Alarms All types

The department responded to a total of one thousand three hundred and two (1,302) alarms during this period. During the same period for 2014 the department responded to a total of one thousand three hundred thirty two (1,245) alarms. This was a 4.57%

increase from the previous year.

Murder Cases:

None reported

Arson Cases:

The department responded to a total of zero (0) reported arson. During the same period for 2014, the department responded to a total of one (1) reported arson. This is a 100%

decrease from the previous year.
