3. Traffic.

3.1. The Cove Center for Grieving Children 5k Race, Memorial Walk and Fun Run request.

3.4. North Fair Street and Cherry Street.

The Chief of Police, the Traffic Sub-Committee and the Town Engineer reviewed the intersection at North Fair Street and Cherry Street and recommended the removal of the one-way signs because they found them unnecessary and confusing for motorists.

Chief Hutchinson reviewed the correspondence received regarding the intersection of Clapboard Hill Road and Tanner Marsh Road. He reviewed the recommendation of the Town Engineer and the three-way stop. Discussion took place.

4.4.1. FYI-For Interceptors 2013-2017 correspondence received from FORD motor company.

Chief Hutchinson reviewed the correspondence received from Ford to the department Referencing carbon monoxide issues with some of the Ford Interceptors from 2013-2017. Discussion took place regarding Ford's perspective on the vehicles.

Chief Hutchinson stated that the department takes these matters seriously. Deputy Chief Hyatt has obtained feedback from Connecticut State Police Manager on how they are addressing the issue. The Chief has assigned Deputy Chief Hyatt to follow up with Ford, the State Police and the Fleet Manager. The department is continuing to stay up to date with the scheduled inspections of the vehicles and

Ford is handling the repairs on any faulty vehicles.

4.4.2. TRANE-Service Contract.

Chief Hutchinson reviewed the TRANE service contract and the budget and expense were discussed. It was agreed that the service contract is necessary. The Chief will include the \$1218.00 annual expense in the budget.

Commission agreed to accept the annual service contract for the HVAC system

at Headquarters as presented for \$1218.00 annually.

6.2. North Guilford Traffic signs.

It was agreed that the State of Connecticut had previously performed an in depth review of the roadways around the Town Green and reestablished new signage. Discussion took place.

Commission voted that upon consulting with the State of Connecticut and in consideration of the recent assessment performed by the State of Connecticut on the roads around the Town Green that the Commission will support the 25 mph

speed limit and there will be no changes made in the speed limit.
