7.1 Board of Police Commission-Officer Elections (no documents)

FBI Special Agent Brian Turner explained the advantages of having a local law enforcement officer assigned as an FBI Task Force Officer.

3. Traffic

3.1. Signage/Traffic Enforcement

3.1.1 2019T10-Request for crosswalk at Concept Park/Village Walk.

This request was originally submitted to the First Selectman's Office, and was reviewed by Town Engineer Janice Plaziak. There currently exists a traffic control signal to allow for pedestrian crossing at this intersection. The Town Engineer's only recommendation for the Police Commission was that they could request that the CT DOT stripe the crosswalk.

Commissioner Mikolay commented that he did not think it would hurt to make the request and let the State determine whether the striping is needed. Commissioner Chello stated that he felt striping the crosswalk was not appropriate, and was superfluous. He noted that striping the crosswalk could be detrimental to traffic flow, and possibly cause more harm than good.

Chief Hutchinson suggested that the department get a pedestrian count at the intersection to further evaluate whether to make a request for a crosswalk from the CT DOT.

Motion: Upon a motion by Commissioner Chello, and seconded by Commissioner Federici,

the Board of Police Commissioners voted to table this item until more information

on pedestrian counts can be obtained.

3.1.2 Request by resident to purchase Speed Awareness Sign.

The Police Department currently has five speed awareness signs deployed around town. Their effectiveness is driven by their random placement and duration of their placement in any one location. The longer they are in a location they lose their effectiveness, as drivers become complacent.

The decision to allow the public to purchase and place speed awareness signs on town roads will be a public policy decision the Police Commission would have to make. The police department would not be responsible for maintaining or replacing the signs. The signs would not change enforcement.

Chairman Welsh felt it would set a bad precedent to allow individual neighborhoods to control street signs on local roads.

The Commissioners agreed that the Chief should advise the resident that the department will continue to support speed control efforts as they have been doing.

4.1 Facilities/Equipment

4.1.1 Facilities/Equipment update (no documents).

Deputy Chief Hyatt advised that Town Facilities Manager Steve Neydorff will provide approximately \$80,000 from the energy conservation funds to replace and upgrade the VAV valves for the HVAC system.

The Dispatch and server areas have their own air conditioning systems that do not pull all the moisture out of those areas. A new system will be installed that preheats the air going into the AC systems to reduce the amount of moisture.

The Commission and Department expressed their appreciation to Facilities Manager Steve Neydorff for his department's efforts to resolve these problems and to secure the funding to make the repairs.
