A set of systematic, analytical processes directed at providing timely and pertinent information relative to crime patterns and trend correlations to assist the operational and administrative personnel in planning the deployment of resources for the prevention and suppression of criminal activities, aiding the investigative process, and increasing apprehensions and the clearance of cases. SUBJECT: Crime Analysis Report February 2021

During the month of February 2021, the Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information. This information was compiled via the NEXGEN system utilizing a query of all Part 1 Crimes and select Part 2 crimes from the computer database. A full review of each queried case file report was completed.

The Guilford Police Department investigated 496 cases for the month of February. This is an eighty-eight percent (88%) decrease in calls from February 2020 (936).

Burglary

There were two (2) reported burglaries during the month of February. Both burglaries were to commercial buildings. One case resulted in an arrest. Both incidents saw forced entry utilized by the suspect(s).

The number of burglaries increased when compared to February 2020 (1).

No graphic representation will be provided due to the minimal number of burglaries for the month of February.

Criminal Mischief

There were two (2) criminal mischief cases for the month of February. One (1) of the cases involved damage to private property and the remaining case to public property. There were no arrests made for criminal mischief in the month of February.

One (1) of the incidents reflects the time the report was filed and not the time at which the crime was committed. This was reported after the damage was observed and the exact time and date of the occurrence is unknown. No trend nor pattern was identified to warrant the development of a response plan.

The number of criminal mischief cases decreased when compared with February 2020 (5).

No graphic representation will be provided due to the minimal number of criminal mischief cases for the month of February.

Larceny

There were seventeen (17) larceny cases reported during the month of February. Two (2) of the cases were solved and one arrest was made. The victim in another case no longer wished to pursue charges upon return of the stolen item. Multiple other cases have suspect information developed and are actively being investigated.

The larceny types are as follows: Seven (7) shoplifting, six (6) thefts from motor vehicle, one (1) theft from mail, and three (3) general larceny.

For five (5) of these larceny cases the exact date and time that the larceny occurred has not been determined. Thus, the date and time shown in the related graph reflects only that of the date/time reported. A separate graph has been provided which depicts day and time the offense was completed, if known.

The number of larceny cases remained the same from February 2020 (17).

The fraud cases for the month of February are as follows: three (3) General Fraud, three (3) Fraud via Internet, one (1) Fraud with a Credit Card, and one (1) Fraud – Identity Theft. These fraud incidents mostly were attempts to defraud victims of funds. In some cases, the involved complainants were reimbursed or did not experience any loss. In total there was \$10,274.41 in losses experienced from these incidents.

Robbery

None reported. This remained consistent with February 2020 (0).

Larceny of MV

There were four (4) stolen motor vehicles during the month of February. This is an increase from the number reported in February of 2020 (1).

Aggravated Assault/Simple Assault

None reported. This is a decrease from February of 2020 (1).

None reported. This remained consistent with February of 2020 (0).

Sexual Assault/ Sex Offense:

None reported. This remained consistent with February 2020 (0).

Homicide

Criminal Activity Information and Intelligence


CTIC provided LEO intelligence during this month. The New England State Police Information Network also served as a source of intelligence as did the Law Enforcement Information Exchange (LInX). Guilford Police also monitors Crimedex Law Enforcement Portal for updated information on financial crime trends. Crime intelligence sharing is also monitored through the New Haven Police Department's SLACK channel as well as internally utilizing the Guilford PD SLACK channel. The Detective Unit continues to monitor social media and the anonymous tip line for gathering and evaluating criminal intelligence.

Intelligence meetings were held for the Middlesex County Detective Association and Shoreline Detectives. New Haven MDT meetings were held virtually in regard to ongoing criminal activity in all attending agencies' jurisdictions.
